**GOLF LEAGUE CONTRACT 2017 SEASON**

WHEREAS THE LEAGUE IS DESIROUS OF RESERVING THE PRIVILEGE OF THE USE OF THE CLUB'S COURSE ON THE DATES AND TIME HEREINAFTER SPECIFIED.

IT IS MUTUALLY UNDERSTOOD, PROMISED AND AGREED THAT THE LEAGUE SHALL RESERVE AND PAY FOR \_\_\_\_\_ TEE TIMES FOR THE LEAGUE EACH \_\_\_\_\_ (Day) FROM APPROXIMATELY \_\_\_\_\_ TO \_\_\_\_\_ FOR \_\_\_\_\_ WEEKS. THE WEEKLY RATE FOR EACH TEE TIME IS \$ \_\_\_\_\_ AND INCLUDES LEAGUE NINE HOLES WITH POWER CART. THE LEAGUES WEEKLY OBLIGATION TO THE CLUB SHALL BE \$ \_\_\_\_\_. PAYMENT FOR LEAGUE PLAY IS REQUIRED TO BE PAID USING THE FOLLOWING SCHEDULE. **HALF (1/2) PAYMENT IS DUE THE FIRST SCHEDULED DAY PLAYING LEAGUE. THE SECOND HALF (1/2) PAYMENT DUE MID SEASON.** PAYMENT IS EXPECTED IN THE FORM OF CASH OR CHECK.

PRIOR TO \_\_\_\_\_, 20\_\_, THE LEAGUE SHALL DEPOSIT \_\_\_\_\_ WITH THE CLUB. THIS SUM IS NOT REFUNDABLE.

**A LEAGUE OFFICER SHALL PAY FOR LEAGUE PLAY ACCORDING TO THE PAYMENT SCHEDULE LISTED ABOVE.** THE CLUB'S POLICIES AND REGULATIONS SHALL GOVERN ALL LEAGUE PLAY AND PLAYERS. THE CLUB RESERVES THE RIGHT, AT ANY TIME, TO REFUSE THE USE OF IT'S COURSE AND FACILITIES TO ANY LEAGUE MEMBERS CONDUCTING HIM OR HERSELF IN SUCH A MANNER AS TO UNDULY OFFEND OTHER PERSONS EMPLOYED BY OR USING THE CLUB'S FACILITIES.

**IT IS AGAINST THE STATE OF MICHIGAN LIQUOR CONTROL COMMISSION LAWS TO BRING AND CONSUME YOUR OWN ALCOHOLIC BEVERAGES ON THESE PREMISES. ANY ONE BRINGING THEIR OWN ALCOHOLIC BEVERAGES TO THIS FACILITY WILL BE SUSPENDED FROM LEAGUE PLAY WITH NO REFUNDS!**

IN THE EVENT THERE ARE NO LEAGUES MEMBERS ON THE TEE AND READY TO BEGIN PLAY AT THE AFOREMENTIONED STARTING TIME, THE CLUB RESERVES THE RIGHT TO BEGIN PLAY "IN THE COURSE" TO MAINTAIN THE CLUB'S TEE TIME SCHEDULE. THE CLUB ALSO RETAINS THE RIGHT TO DELAY THE TEE TIMES OF THOSE INDIVIDUALS IN THE LEAGUE WHO ARE NOT ABLE TO TEE OFF BY THE LAST SCHEDULED TEE TIME. THE TEE TIME SCHEDULE FOR THE LEAGUE AND ALSO THOSE LEAGUES THAT FOLLOW IN SUCCESSION WILL BE FOLLOWED AND ENFORCED BY THE CLUB'S EMPLOYEES. THE CLUB ALSO RESERVES THE RIGHT TO POSTPONE LEAGUE PLAY ON ALL HOLIDAYS AND UP TO TWO OTHER TIMES DUE TO GOLF OUTINGS OR TOURNAMENTS. THE CLUB RESERVES THE RIGHT TO CHANGE TIMES AND OR RATES (WITHIN REASON) WITH

WRITTEN NOTICE TO THE LEAGUE OF SUCH CHANGES.

IN THE EVENT OF INCLEMENT WEATHER, THE CLUB SHALL MAKE THE DETERMINATION OF AND BE THE SOLE JUDGE AS TO WHETHER OR NOT THE COURSE IS PLAYABLE AND WHETHER OR NOT LEAGUE PLAY IS CANCELLED. FURTHER, IN THE EVENT OF A WEATHER DELAY LEAGUE PLAY MUST BEGIN WITHIN 15 MINUTES OF THE FIRST SCHEDULED TEE TIME. IN THE EVENT OF A POSTPONEMENT DUE TO INCLEMENT WEATHER OR HOLIDAYS, ALL LEAGUES WILL CONTINUE IN THE SAME SCHEDULED WEEKLY ROTATION AS FAR AS ALTERNATING NINES FROM WEEK TO WEEK. DURING INCLEMENT WEATHER ANY LEAGUE IN WHICH 50% OR MORE OF THE LEAGUE MEMBERS HAVE COMPLETED FOUR OR MORE HOLES OF GOLF WILL BE CONSIDERED TO HAVE COMPLETED ITS LEAGUE NINE. ALL CANCELLED PLAY MUST BE RESCHEDULED.

**THE GOLF CLUB AND THE LEAGUE UNDERSTAND THAT THE RENEWAL OR TERMINATION OF THE AGREEMENT FOR THE 2017 SEASON MUST BE SIGNED PRIOR TO SEPTEMBER 30, 2016, OTHERWISE THE TIME WILL BE UNDERSTOOD TO BE OPEN TO OTHER INQUIRIES. NO LEAGUE WILL BE RECOGNIZED UNLESS A SIGNED CONTRACT IS ON FILE WITH THE CLUB AND THE LEAGUE DEPOSIT HAS BEEN PAID PRIOR TO SEPTEMBER 30, 2016.**

IT IS FURTHER AGREED THAT NO ORAL OR WRITTEN AGREEMENTS HAVE BEEN ENTERED INTO BETWEEN THE PARTIES. THIS CONTRACT COVERS THE ENTIRE AGREEMENT BETWEEN THE PARTIES HERETO.
